PRELUDE PITCH

Prelude Pitch offers an opportunity for entrepreneurs to present their business ideas to a panel of seasoned professionals and receive constructive feedback. This platform helps start-ups refine their pitches, gain insights into market readiness, and improve their presentation skills, providing valuable preparation for securing investment and partnerships.

RURAL BUSINESS INNOVATION INITIATIVE (RBII)

RBII fosters innovation and support business growth in rural Maryland by providing funding, resources, and guidance. This program targets tech-driven companies, helping them scale and compete in the broader marketplace, while creating economic opportunities outside of urban centers. Eligible startups receiving mentorship through this initiative can apply for a \$10k Project Grant and/or \$25k in Concept Capital based on their rural status.

URBAN BUSINESS INNOVATION INITIATIVE (UBII)

UBII focuses on technology-based businesses in urban Maryland, supporting the growth of early-stage ventures through resources, grant funding, and expert mentorship. The initiative promotes economic development, job creation, and innovation, helping businesses grow and thrive in competitive industries. Eligible startups receiving mentorship through this initiative can apply for a \$10k Project Grant.
